## Subject: Revision of Inbound Policy

Our Letter No 801/A/Ops-III/NCOC-01 dated 07 February 2022 referred.

1. Inbound policy was reviewed at NCOC and following health / testing protocols will be applicable for inbound passengers with effect from 0001 PST, 24 February 2022: -

- a. **Pre-boarding negative PCR has been abolished for fully vaccinated** inbound travelers. However, non-vaccinated individuals over 12 years will require pre-boarding negative PCR (72 hours old).
- b. **Mandatory full vaccination** for all inbound passengers less exemptions granted vide our letter no 801/A/Ops III /NCOC-01 dated 06 January 2022.
- c. Passengers below 12 years of age are exempted from mandatory vaccination.
- Passengers between 12-18 years of age are allowed to travel without mandatory vaccination till 31<sup>st</sup> March 2022.
- e. RAT on arrival for deportees and non-vaccinated pedestrians at Border Terminals;
  Positive cases will be home quarantine for 10 x days.

### Subject: Revision of Inbound Policy - Abolishment of RAT on Arrival

Our Letter No 801/A/Ops III /NCOC-01 dated 30 September 2021 and 801/A/Ops III /NCOC-01 dated 03 January 2022 and 801/A/Ops III /NCOC-01 dated 06 January 2022 and our letter no 801/A/Ops III /NCOC-01 dated 31 January 2022 referred.

1. RAT on arrival has been abolished **with effect from 8 February 2022** for inbound travelers / pedestrians (Border Terminals) except following categories: -

- a. Deportees travelling without mandatory pre-boarding negative PCR (max 48 hours).
- b. Non-Vaccinated pedestrians at Border Terminals.
- 2. Following pre-boarding protocols must be ensured: -
  - a. Vaccination for all inbound passengers except exempted from mandatory vaccination as already intimated vide our letter no 801/A/Ops III /NCOC-01 dated 06 January 2022 and our letter no 801/A/Ops III /NCOC-01 dated 31 January 2022.
  - b. Pre-boarding Negative PCR (max 48 hours old).

 Owing to the introduction of Obligatory vaccination regime, there is a requirement to revise Inbound / Outbound COVID related health protocols. Instructions / directions spelled out in succeeding paras will be implemented with immediate effect: -

- a. Inbound Travel (Air / Land / Sea)
  - (1) <u>Negative PCR Before Boarding</u>. All pax of 06 years age and above (Locals / Foreigners) are required to be in possession of Negative RT PCR Test Report (max 72 hours old) before boarding. Deportees are exempted from RT PCR Test / Report requirement.
  - (2) <u>Vaccination for Entry into Pakistan.</u> All Pax of 18 Years and above age (Locals / Foreigners / Diplomats) coming through Air / Land/ Sea will be required to be in possession of Complete Vaccination Certificate / Proof of Complete Vaccination while entering in Pakistan / before boarding with effect from 1 October 2021 with following exceptions: -
    - (a) Foreigners / Foreign Passport holders less than 18 years of age are allowed to enter Pakistan through Air / Land / Sea without Vaccination.
    - (b) Pakistani Pax less than 15 Years of age are allowed to enter Pakistan without Vaccination Certificate.
    - (c) Pakistani Students less than 18 years of age who are studying abroad are allowed to enter Pakistan without Vaccination Certificate. However, they will be required to be vaccinated while returning back.
    - (d) Pakistani pax between 15 to 18 Years of age are allowed entry in Pakistan through Air / Land / Sea without Vaccination till 1 November 2021.

Obligatory Vaccination Regime - Revised Inbound / Outbound Air, Land, Sea Travel and Domestic Air Travel COVID Related Protocols

- (e) Pakistani pax between 15 to 18 years of age coming through Air / Land / Sea will be required to be in possession of Partial Vaccination Certificate / Proof of Partial Vaccination i.e atleast one dose before boarding with effect from 1 November 2021. Full Vaccination Certificate / Proof of Full Vaccination for Pax between 15 to 18 years of age will be mandatory with effect from 1 December 2021.
- (f) Pax (Pakistani / Foreigner) with valid medical reason for exemption of vaccination issued by Doctor (certificate from classified specialist) coming through Air / Land / Sea are allowed to enter Pakistan without Vaccination Certificate.
- (g) Pax (Pakistani / Foreigner) who have travelled outbound from Pakistan before1<sup>at</sup> October 2021 are allowed to enter Pakistan from Air / Land / Sea without vaccination certificate. Furthermore, pax travelling through connecting flight after entering Pakistan will be allowed to continue their domestic travel.
- (h) Owing to the obvious reason, vaccination regime is not applied on Deportees coming through Air / Land / Sea.
- Afghani Inbound pedestrians can travel to Pakistan through Border Terminals without partial / full vaccination certificate. However, they will undergo stringent testing / quarantine protocols as already in-placed.
- (3) <u>Rapid Antigen Test at Airports / Border Terminals (BTs)</u>. All pax (Locals / Foreigners) of 6 years and above will undergo RAT Test at arriving airports / Border Terminals. Details / exceptions are as under: -
  - (a) Diplomatic passport holders are exempted from Rapid Antigen Test (RAT) at arriving airports / BTs. However, diplomats will self-quarantine at their respective residence for 10 x days. Diplomats willingly undergoing RAT are exempted from Home Quarantine requirement.
  - (b) Diplomats not in possession of Valid Vaccination Certificate / Proof of Vaccination, will undergo RAT at their facilities (MoFA to ensure).
  - (c) Positive cases of RAT from Air Travel (Local / Foreigners) will be Quarantined for 10 x Days at Govt / Self Paid Quarantine facility.
  - (d) RAT positive cases from Land Travel (Local / Foreigners less Afghanis) will be Quarantined for 10 x Days at Govt / Self Paid Quarantine. However, RAT positive Afghanis from Land Travel will be reverted back.

- (e) RAT positive Afghanis from Land Travel coming on Mol letter as part of evacuation process will be quarantined inside Pakistan.
- (f) RT PCR test of all RAT positive quarantined pax will be undertaken on 8<sup>th</sup> Day of quarantine. In case of negative result, pax will be allowed to proceed home. However, in case of positive result, pax will either undergo additional quarantine period or will be shifted to hospital as per advice of health authorities.
- (g) RAT Negative cases (Local / Foreigner) coming from Air / Land/ Sea Travel will be allowed to proceed home without quarantine.
- (4) Mandatory Registration on Passtrack
  - (a) Mandatory registration on Passtrack App by all inbound travelers before traveling to Pakistan.
  - (b) Deportees are exempted for registration on Passtrack App.
- b. <u>Outbound Travel (Air / Land / Sea)</u>. Only Fully Vaccinated Pakistani Pax of 18 Years and above age will be allowed to exit Pakistan through Air / Land / Sea with effect from 1<sup>st</sup> October 2021 with following exceptions: -
  - Foreigners / Foreign Passport holders will be allowed to exit Pakistan through Air / Land / Sea without Vaccination Certificate.
  - (2) Pakistani pax less than 15 Years of age are allowed to exit Pakistan through Air / Land / Sea without Vaccination Certificate.
  - (3) Pakistani pax between 15 to 18 Years of age are allowed exiting Pakistan through Air / Land / Sea without Vaccination till 01 November 2021.
  - (4) Pakistani Pax between 15 to 18 years of age exiting Pakistan through Air / Land / Sea will be required to be in possession of Partial Vaccination Certificate / Proof of Partial Vaccination i.e at least one dose before boarding with effect from 1 November 2021. Full Vaccination Certificate / Proof of Full Vaccination of Pax between 15 to 18 years of age will be mandatory with effect from 1 December 2021.
  - (5) Pax who have travelled to Pakistan from other countries before1<sup>st</sup> October 2021 are allowed to exit Pakistan from Air / Land / Sea without vaccination certificate. Furthermore, pax travelling through connecting flight for exiting Pakistan will be allowed to continue their domestic travel without vaccination certificate.
  - (6) Pax with valid medical reason for exemption of vaccination issued by Doctor (certificate from classified specialist) exiting through Air / Land / Sea are allowed to exit Pakistan without Vaccination Certificate.

- (7) Afghanis outbound pedestrians can travel to Afghanistan from Pakistan through Border Terminals without partial / full vaccination certificate.
- c. <u>Domestic Air Travel</u>. Only Fully Vaccinated Pax of 18 Years and above age (Locals / Foreigners / Diplomats) will be allowed Domestic Air Travel with effect from 1<sup>st</sup> October 2021 with following exceptions: -
  - All Foreigners / Foreign Passport holders less than 18 years of age are allowed Domestic Air Travel without Vaccination.
  - (2) Pakistani pax less than 15 Years of age are allowed Domestic Air Travel without Vaccination.
  - (3) Pakistani pax between 15 to 18 Years of age are allowed Domestic Air Travel without Vaccination till 01 November 2021.
  - (4) Pakistani Pax between 15 to 18 years of age will be required to be in possession of Partial Vaccination Certificate / Proof of Partial Vaccination i.e at least one dose for Domestic Air Travel with effect from 1 November 2021. Full Vaccination Certificate / Proof of Full Vaccination of Pax between 15 to 18 years of age will be mandatory for Domestic Air Travel with effect from 1 December 2021.
  - (5) Pax with valid medical reason for exemption of vaccination issued by Doctor (certificate from classified specialist) are allowed Domestic Air Travel without Vaccination Certificate.
  - (6) Foreigners / Foreign Passport holders who have travelled to Pakistan from other countries before 1<sup>st</sup> October 2021 are allowed to continue their domestic travel without vaccination certificate.

#### Subject: Revision of Inbound Air Passengers Travel Categories

Our Letters No 801/A/Ops-III/NCOC-01 dated 05 December 2021 and No 801/A/Ops-III/NCOC-01 dated 19 December 2021 and 801/A/Ops III /NCOC-01 dated 28 December 2021 referred.

#### 1. Category 'B' and Category 'C' have been abolished with effect from 0001 PST, 5 January

2022. However, following health protocols will continue to be applicable: -

- a. Vaccination is mandatory for all inbound passengers.
- b. Negative PCR report before boarding (maximum 48 hrs old).
- c. 100% RAT on arrival for all direct flights from Europe.
- d. Minimum 50% flights from KSA, UAE and Qatar will undergo RAT on arrival.
- e. Selected RAT on arrival for flights other than mentioned in Para 2c and 2d, above.
- f. RAT positive cases will be guarantined for 10 days followed by PCR test on 8th day.

 Exemption / Waiver. Pakistanis unable to get themselves vaccinated abroad (all categories) due to following reasons are exempted from mandatory vaccination after producing valid proof to airline / immigration authorities before boarding: -

- a. Expired Visa or illegal immigrants / deportees.
- b. Medical conditions / issues.
- c. Pregnant women.

3. <u>Aviation Division / CAA only</u>. Please ensure staggering of flights (specially flights from Europe) to afford sufficient time for RAT on arrival by **5 January 2022**.

4. CHE Only. Please ensure following: -

- a. Ensure all inbound passengers arriving via direct flights from Europe and minimum 50% passengers from KSA, UAE and Qatar are tested through RAT at all designated airports in coordination with provincial health / airport authorities.
- Ensure availability of requisite health staff round the clock at all major airports in coordination with provincial health authorities.
- c. Maintain sufficient stock of RAT kits and allied equipment at designated airports. Kits requirement on the basis of new testing protocols for one month duration be shared with NCOC by 4 January 2022.
- 5. MoNHSR&C Only. Ensure availability of additional health care staff at designated airports.
- 6. Provincial / ICT Administration Only. Please ensure to arrange following: -
  - Arrange / manage adequate quarantine facilities (Government / Self-paid) within proximity of major airports.

- b. Transportation of RAT positive passengers from airports to designated quarantine facilities.
- Beef up CHE staff with provincial health staff at respective Airports (on requirement basis) in the province.
- d. AJK and GB are requested to assist federating units especially Rawalpindi and ICT administration for smooth management of AJK / GB related inbound travelers landing at IIAP.

7. <u>MoFA Only</u>. Please disseminate information to all Pakistan High Commissions and Embassies and assign priority for information of Pakistani diaspora.

 NDMA only. Please ensure availability of sufficient RAT kits in coordination with NCOC / MoNHSR&C.

9. MoIT / NITB. Please ensure uninterrupted / continuous availability of Pass track App.

10. Revised air travel plan will be effective from mid night 5 January 2022.

### Review of Inbound Travel Policy will be carried out at NCOC on 15 February 2022.

#### Subject: Exemption from Mandatory Vaccination for Inbound Pax

Our Letters No 801/A/Ops III /NCOC-01 dated 30 September 2021 and No 801/A/Ops III /NCOC-01 dated 3 January 2022 referred.

 Updated Exemptions from mandatory vaccination for selective inbound pax as explained in Obligatory Vaccination Policy letter dated 30 September 2021 and amendments added vide NCOC Letter No 801/A/Ops III /NCOC-01 dated 3 January 2022, are enlisted below for further clarity / guidance of overseas diaspora: -

- Expired Visa holders or illegal immigrants / deportees are exempted from mandatory vaccination because of obvious reasons.
- b. Pax (Pakistani / Foreigner) with valid medical reason for exemption of vaccination issued by Doctor (certificate from classified specialist) coming through Air / Land / Sea are allowed to enter Pakistan without Vaccination Certificate.
- c. Pregnant women are exempted from mandatory vaccination.
- d. Passengers between 15 to 18 years of age exempted till 15 February 2022 (as already communicated vide our letter no 801/A/Ops III /NCOC-01 dated 3 January 2022).
- Pakistani Pax less than 15 Years of age are allowed to enter Pakistan without Vaccination Certificate.
- f. Foreigners / Foreign Passport holders less than 18 years of age are allowed to enter Pakistan through Air / Land / Sea without Vaccination.
- g. Pax (Pakistani / Foreigner) who have travelled outbound from Pakistan before1st October 2021 are allowed to enter Pakistan from Air / Land / Sea without vaccination certificate. Furthermore, pax travelling through connecting flight after entering Pakistan will be allowed to continue their domestic travel.
- Afghani inbound pedestrians can travel to Pakistan without vaccination certificate; however, they will undergo vaccination (preferably single dose vaccines) at respective Border Terminal.
